1. Feline parents _____ color _____

 2. Under no condition will this feline be sold to a pet shop or research lab.
 3. If the buyer at any time decides to sell feline, seller has first choice on the cat.
 4. INDOOR sanitary conditions will be provided for the feline and it will not be allowed to roam outdoors at any time.
 5. If feline is found to be neglected for any unreasonable amount of time, buyer agrees to surrender feline unconditionally.
 6. Seller will provide buyer with feline registration blue slips and will worm the feline at least once before delivery.
 7. Seller guarantees the health quality of this feline against fatal genetic defects for a period of 1 year. Feline will be replaced with a comparable kitten if documented proof is provided by a licensed vet.
 8. Buyer agrees to provide the feline with all normally required vaccinations shown in a health record.
 9. Seller assumes no responsibility or liability of the feline after leaving premises of the cattery due to landlord's disapproval, vet medical expenses, mortality due to negligence, accidents, feline injections, allergy to animal or for damages caused by this feline.
 10. No guarantee is given on the final appearance, or of the adult disposition, nor the nature of breeding ability or of producing offspring.
 11. Seller warrants the feline is in good health upon delivery of the kitten. Buyer is required to have the kitten examined by a licensed veterinarian at their sole expense within 72 hours of pick up or receipt of the kitten for the health guarantee to be fulfilled. Failure to do so will make the health guarantee null and void. If the vet exam reveals a serious illness, the buyer must provide proof from a licensed veterinarian to the seller within 24 hours of the exam. Kitten may be exchanged if a serious documented illness is found by the vet.
 12. Buyer agrees there are common infections that cats are often subject to such as FIP which can be contracted at any point in time. Seller is not responsible for any infections and common cat maladies contracted once the cat leaves the cattery. Seller will not be held responsible for ringworm or any type of common feline infections known to affect cats once the cat is picked up or transported.
 13. Buyer agrees to have the feline spayed/neutered by _____.
- BUYER MUST FURNISH WRITTEN PROOF FROM A LICENSED VET OF THE PROCEDURE BY ABOVE DATE OR THEY WILL OWE THE FEES FOR BREEDING RIGHTS. BUYER WILL BE BILLED AND LEGAL ACTION WILL BE TAKEN IF MONIES FOR SAID RIGHTS ARE NOT RECEIVED WITHIN 30 DAYS OF BILLING. BREEDING RIGHTS FEES _____**

14. Buyer agrees to pay the balance of feline purchase and breeding rights prior to pickup or delivery unless special arrangements are made. Balances paid at pick up **MUST BE IN CASH**. Balances paid prior to shipment or pickup using a check must be made at least 2 weeks prior to scheduled delivery date to allow for clearance of the check. No felines will be released until all balances are paid in full.
